Shumate)

- Insurance perspective. Considerations of what constitutes a reimbursable procedure, What is covered and what is not, how are the reimbursement levels determined, issues that surgeons and medical centers be aware of when introducing new innovations/techniques/technologies (M. Mugiishi)
- The Perspective from Kaiser Permanente - training, proctoring, outcomes, patient safety, financial considerations, and healthplan coverage issues (E. Matayoshi)

The Charles Judd Memorial Banquet speaker will be Glenn Furuya, renown leadership and empowerment speaker, and his topic is Leadership in the OR: The Responsibilities of the Surgeon and RN.
